## FY 2017 CDBG – Development of the soccer field

The silt fence has been installed in advance of the project start-up. We are meeting with the contractor on site early next week and will have an update then.

# FY 2019 CDBG - Sanitary Sewer Improvements at Golf Road

The contractor, Eagle Contracting Inc., has been awarded the bid. We are in the process of preparing and executing contracts.

FY 2020 CDBG – Applications are due in the beginning of January. The Borough is able to apply for two projects. It is recommended we continue with the replacement of the sanitary sewer on Golf Road as one of the projects. Public input will be obtained on December 18, 2019 at 7:00PM.

# 2018 PA Small Water and Sewer Grant

We can begin the sewer replacement in the Chestnut St area whenever the Borough is ready to authorize it. This is a reimbursement grant. The Borough must pay the contractor first, and then request reimbursement.

## Ordinary Street and Sewer Maintenance

A to U has ordered the inlet box for the inlet at Crestview/Southridge. They are also replacing the inlet on the opposite side of the street.

The contractor, A.F. Damon, has fixed the patch on Ridge Avenue opposite of Borough Hall.

## MS4 Separate Storm Sewer Permit

The annual report was submitted to DEP.

# Main Street Intersection Improvements

Intersection improvements are being proposed at the intersections of Main Street at 5<sup>th</sup> and 6<sup>th</sup> Streets. Can this project use the same traffic detour plan as was used several years ago for the new railroad crossing "diamond plates" installed by CSX RR? That detour used Borough streets Church Lane, S. 70<sup>th</sup> St., and Woodland Ave. Please verify with police and other agencies if the same route is acceptable.

## November Chief's Report

Dear Mr. President, Board of Directors, and General Membership,

During the month of November the company responded to 85 calls for service. These calls included 2 working fires, 1 in Collingdale and 1in East Lansdowne. The company also handled an Accident with Entrapment in Darby.

On November 14<sup>th</sup>, Co. 4 and mutual aid were dispatched to the intersection of 4<sup>th</sup> and Walnut for the accident with entrapment. Upon arrival 1 patient was located in the vehicle, requiring extrication, the patient was removed via windshield removal and turned over to EMS. Captain 4 had the command.\*No FF injuries were reported at this incident.\*

On November 20<sup>th</sup>, Co 4 was dispatched to the 600 block of Hibberd Ave for a garage fire. Co. 4 assisted with suppression and overhaul after a small fire was located and extinguished in the garage. E4 was in service for 40 minutes. .\*No FF injuries were reported at this incident.\*

On November 25<sup>th</sup>, Co. 4 was dispatched to the 200 block of Hirst Ave in East Lansdowne for the basement fire. Upon arrival Truck 4 took first due truck, assisted E16 with suppression, overhaul and ventilation. Asst. 24 had the Command. .\*No FF injuries were reported at this incident.\*
