FY 2017 CDBG – Development of the soccer field

DEP has approved the construction plans. We will have a schedule from the contractor soon.

FY 2019 CDBG - Sanitary Sewer Improvements at Golf Road

Eagle Contracting started the work on January 27, 2020. They have finished the main and lateral replacements and will be televising the line early next week.

<u>FY 2020 CDBG</u> – An application for using CDBG funds as a supplement to the 2018 PA Small Water and Sewer Grant for the replacement of the sanitary sewer and street resurfacing of 13th St was submitted on 1/9/2020.

2018 PA Small Water and Sewer Grant

If the Borough receives a CDBG award, we will be able to do the effort funded by this grant. The announcement should be made in May.

Ordinary Street and Sewer Maintenance

A to U has replaced the one inlet at Crestview and Southridge closest to the Creek.

MS4 Separate Storm Sewer Permit

The annual report was submitted to DEP.

Stormwater Tip:

Recycle used motor oil. Find out if your local community, gas stations, or businesses that sell motor oil and provide oil changing services that will accept used motor oil and then take it there. Whatever you do, never dump motor oil, gasoline, radiator fluid, automotive solvents, etc. down a storm drain.

January Chief's Report

Dear Mr. President, Board of Directors, and General Membership,

During the month of January the company responded to 65 calls for service. These calls included 1 working fire in Darby and 2 accidents with people trapped in Darby.

on January 18th Co. 4 and mutual aid were dispatched to the 700 Block of Main St. for the house fire with entrapment. E4 arrived to find a 2.5 story SFD with smoke showing from the first floor and a resident inside attempting to extinguish the fire and the other on the porch roof. 47 cars assisted the resident off the roof via ground ladder and E4 crew assisted the resident out of the home and began fire suppression. The fire was quickly contained to the first floor dining room. Asst. 4 had the Main St. command. Company 4 returned available in just over an hour. **No injuries were reported**

On January 19th Co. 4 and mutual aid were dispatched to MacDade and Ridge for the accident with people trapped. E4 arrived to confirm 1 person trapped in the vehicle. E4 stabilized the vehicle and controlled the hazards while SD16 performed the extrication. Lt. 4A had the MacDade Blvd command. Companies returned available in 30 minutes. **No injuries were reported**

On January 29th Co. 4 and mutual aid were dispatched to Walnut and New Walnut for the accident with people trapped. Upon arrival E4 located a vehicle into a tree with the occupant trapped. E4 and T4 quickly went to work stabilizing and extricating the patient. R33 anchored the vehicle with the bumper winch until the tow truck arrived. T4 officer had the Walnut St command. Companies were available in just over an hour. **No injuries were reported **
