Ordinary Street and Sewer Maintenance

Notices of Award have been sent to the following contractors for the following Lots: Sanitary sewer maintenance to A Gargiule & Sons for Lots 1, 2, 5, & 6 for an initial contract award of \$50,000 with incremental increases as work is identified; Street maintenance to A.F. Damon for Lots 4 & 8 for an initial contract award of \$50,000 with incremental increases as work is identified; and Storm Sewer Maintenance to Ernel, Co. for Lots 1, 3, 5, & 7 with an initial contract award of \$25,000 with incremental increases as work is identified. Ernel, Co. and A.F. Damon contracts have been delivered to the Borough for final signatures. A. Gargiule & Sons contracts are still being executed by the contractor.

Grants

2017 CDBG: Delivery of the soccer field netting is the final item to be completed.

2021 CDBG: Priority and Alternate Project Applications were submitted electronically on January 6, 2021. The Priority Application requested funds to make sanitary sewer improvements on 13th Street. The Alternate Application requested funds to make sanitary sewer improvements on the 200 block of N. 2nd Street.

Stormwater Tip:

Sweep deicing salt or sand residue from the driveway and walkways following a winter storm event. Otherwise, it can make its way into a storm sewer inlet during a rain event. If you do notice excess deicing salt or sand following a winter storm event, consider applying a lesser amount the next time.
